Limited Membership: Limited members own no equity interest in the property of the Club, may not vote or hold office, nor have mooring privileges. Limited Members may become regular Members upon payment of all applicable fees, assessments and dues.

Initiation Fee and Dues: Initiation fee is a one-time payment. All dues are annual, invoiced in January of each year. For new members, the first year annual dues are pro-rated. Upon application approval, initiation fee and dues are non-refundable.

Upon approval of your application, you will be contacted by a member of the Membership Committee and welcomed to STYC. Members are bound by the St. Thomas Yacht Club Bylaws.

* When either a dependent of a Regular Member or a Junior Individual Member reaches age 24 and their club privileges cease, they may apply for membership in the classification desired before their 25th birthday in which case the initiation fee shall be waived.

** A Young Couple/Family or Young Individual applicant may defer payment of the Initiation Fee until age 36. A Young or Junior Applicant deferring the initiation fee must pay their prorated annual dues upon application.

Employee members may be changed annually if presented to the STYC Membership Committee prior to the December Board Meeting. Additional employee members may be added at any time and will be charged pro-rated dues for the remainder of the calendar year. Included in the Corporate Membership for each employee/family is Boat Access for the Hobie Waves and use of the STYC owned Opti's and 420's. Check out is required and Boat Access may be limited during club events and training sessions.

Corporate Membership requires approval of the STYC Board of Governors. The Application will be reviewed by the Board at the next scheduled monthly meeting following receipt.

¹Employees with a spouse or partner, or children under the age of 24, must have a Couple/Family Membership for an additional \$620 which will be billed directly to the employee and must be paid prior to the use of the club. For single employees with children that will use the club, there is an option of a \$200 Junior Membership for the child.
